Good news on the town's overall project. The town has been awarded a US Forest Service Program grant in the amount of \$400,000.

Because of Covid-19, several of the face-to-face meetings needed to move our Railway portion of the project forward are delayed. I have continued to work on the Railway facilities designs from home. I am still hopeful that we can break ground sometime in 2021.
