A TOURIST RAILROAD IN BUTTE FALLS?

NEW LOCOMOTIVES OF GIANT TYPE START OPERATION

Here's an interesting news article dated May 9, 1924. It is from the Portland Clarion and it announces the arrival of heavy 2-10-2 steam locomotives to operate between Roseburg and points in northern California on Southern Pacific's Siskiyou Line.

Southern Pacific's first 2-10-2s were built in 1917, but it appears the article was saying these were "new" locomotives. If so, then these were part of a batch of 52 F-5 Class 2-10-2s built by Baldwin in 1923-1925 and numbered 3718 through 3769. The driver dimensions match the article, but the engine weight of the F-5s was slightly more.

It's interesting in that the 2-10-2 wheel arrangement was named after the first railroad to use them - the Santa Fe, but the newspaper refers to them as decapods, and SP men always referred to them as "Decks". SP ran these "decks" right up to the end of steam operations on the Siskiyou Line (1955), and many photographs have been taken of them climbing Siskiyou Summit. - Tony Johnson

NEW LOCOMOTIVES OF GIANT TYPE START OPERATION (From the Portland Clarion)

Roseburg, May 9. - One of the new decapods, the new mountain type locomotives put into use between Roseburg and points in California, was driving to Roseburg this week. This monster locomotive is bigger than any other engine in the west except those of its own class and has almost twice the pulling power of the locomotives which have formerly been in use.

The big mogul is 98 feet long, and has ten drive wheels, five on each side. The drivers are 63 inches in diameter, the cylinders have a 27½ inch bore and a 33½ inch stroke, and the weight on the drivers (not over all) is 373,900 pounds.

The engine was brought to Roseburg by H.F. Ogden, engineer, and F.A. Fretwell, fireman. It left this afternoon pulling a southbound freight made up of 65 cars. The ordinary engine handles 30 to 35 cars. W.H. Davis, engineer, and L.S. McCarty, fireman, were in the cab on the trip south.

Nineteen of these engines will be in operation south of Roseburg within the next 10 days. The city is as far north as the big engines will go, and in order to handle them in the yards here it was necessary to install a new electric turntable, as the old one was not large enough to do the work.

- 1. Call to Order: Meeting was called to order at 7:56 PM by President E. Don Pettit

- 3. Consent of Agenda: The Agenda was accepted by consensus.
- 4. Approval of the September, 11, 2012 Board minutes: Jerry Hellinga moved to accept the minutes of the September 11, 2012 meeting of the Board of Directors as presented. John Powell seconded the motion which passed unanimously.
- 5. Treasurer's Report Jerry Hellinga: Larry Tuttle moved to accept the Treasurer's report as presented. John Powell seconded the motion which passed unanimously.
- 6. Standing Committees & Projects:
 - a. Medco #4 Restoration Jerry Hellinga

Work on the boiler to prepare it for remounting it on the frame continues. Painting about 80% completed. There is still much to do including an updated ultrasound survey, about 200 staybolts to drill, another hydro test, and repairs on the steam engine before the boiler can be reunited with the frame.

- 9 Member donations totaling \$3,260.00
- 6 non-member donations totaling \$750.00
- Anonymous from Sunday run days and other events totaling \$241.50
- Total donations qualifying for matching funds \$4,251.50
- Other income totals \$1,446.60
- Total funds raised since 4/1/12 including matching funds \$9,949. 60

 - Will be trying boxed fruit drinks at next run day at \$.75 ea.
 - The roof over the "breezeway" between the two buildings needs to be replaced. Allen Dobney, Ric Walch and Larry Tuttle will work on what needs to be done.
- c. Newsletter Allen Dobney
 - As of the November issue we will be down to 44 US mail deliveries from 52 in October. Email delivery over 60.
 - In need of articles for next month's issue.
- d. Park Committee Ric
- e. Membership Allen Dobney
 - Flyers and applications now at 17 Rogue Valley locations.
- f. Railroads in the Rouge Valley traveling exhibit Allen Dobney
 - Direction of the project has changed. Now focusing on 1890 through 1927.
 - The model display will be N scale. I am putting together the diorama and Victoria is supplying the train.
 - This display has been incorporated into the submission for the chapter's display area at the upcoming Rogue Valley Model RR show.
- g. Web Site Updates Larry Tuttle
 - Online version of the Manifest is up to date.
 - Still need soft copies of Ric's newsletters to update back issues on the web.
- h. Museum Bookcase Cabinet Doors Larry Tuttle
 - Stained and ready to lacquer
 - Hardware purchased
 - Mark Martin of Arrow Mountain Windows has used glass which he will install before the doors are mounted on the bookcases.
 - Have received two large boxes of books and magazines from Vere Perry, an elderly, long-retired SP engineer in Roseburg. Many of the books will be significant contributions to our library.
- i. Butte Falls Museum Opportunity Ric Walch

- On September 27, 2012 the Chapter board and several other chapter members me with the citizens of Butte Falls to discuss the possibility of a tourist railroad.
- The presentation was well received with many questions from the audience.
- From this meeting our chapter took the action to do a survey to get a greater level of feedback from the community.
- Survey will be in the November issue of the Butte Falls Bulletin going to 450 households. Drop off boxes will be at 4 locations in town. This survey will cost the Chapter \$60 to have it included in the Butte Falls Bulletin.

7. Old Business:

- a. Fence move & Track extension Project: Ken Hill may take the lead to get this project underway. Allen Dobney offered to help with email notices about work parties.
- b. Sale of surplus / Duplicate Material: Larry has nothing new to report; another member is needed to help with this project.
- c. The use of Chapter property and equipment for photo shoot: Larry drafted a Liability Release and Donation Agreement (attached) to be signed by anyone wanting to do a photo shoot or otherwise use Chapter property and equipment for non-Chapter functions. Jerry Hellinga moved to adopt this form. John Powell seconded the motion which passed unanimously.

 - Ric Walch reported that the CB&Q caboose has leaks in the roof which need to be addressed before the rains hit. Discussion followed about needed repairs.
