Train Trivia, does anyone know when the first train robbery from a moving train took place? I didn't, until I was watching a show on the history channel.

As the story was presented on the History Channel, the first (moving) train robbery in the U.S. took place in 1866. A Gang known as the Reno gang held up a train and made off with some $\$ 10,000.00$ ! That was a boatload of money back then!. They robbed the Ohio \& Mississippi train in Jackson County Indiana.

Apparently, before the Reno gang's big haul in 1866, the only other robberies on trains took place when the train was sitting at a station or freight yard.

Apparently, this method of robbery caught on fast, as they could rob the trains in remote locations with little or no law enforcement close by. As the economy was on the rise during this time period, trains often carried large stashes
of cash and precious minerals. The remote areas where the trains would pass through were the perfect place to stop a train, hop on one, and to head to a remote hideout afterward.

The Reno gang consisted of four brothers and some associates. They reign of terror last about 2 years, when they were finally captured after, according to the program, the Pinkerton Agency set a trap. They put out the word that a certain train would be carrying over $\$ 100,000.00$ in hopes that the Reno gang would find this too good to pass up.

They were right, there was the typical "shootout" and some of the gang was caught right there and the rest were rounded up shortly thereafter. In December of 1868, a mob stormed a jail in Indiana where the bandits were being held, and handed out some western vigilante justice, hanging the brothers Frank, Simeon and William. The other brother John had been caught earlier and had already been sent to prison, along with his fellow gang member Charlie Anderson.

Thankfully, this new method of robbery did not last too long. By the late 1800's, the train officials and law enforcement had gotten wise and fought back, by protecting their cargo and trains with safes, and armed guards. Thus, making this "career" choice increasingly dangerous.

This story is as I heard it and was told on the History Channel, from my research it appears to be accurate.
