Dan Wilkinson's GP30 Locomotive By
Allen Dobney

Dan's GP30 was built in October 1962, #27635, FN 7628-19, as B&O 6918, Class FSE-5. It was reclassified Class GP-30 in 1964 and later rebuilt as Class GP-30M in October 1982.

It was renumbered 4239 in 1986 when it became CSX locomotive, Class GP-30M, in 1987.

It was retired on August 29, 1995, and sold to Ohio. Central RR on December 7, 1995, It became Columbus & Ohio River RR 4239 in February 1996 and then Arizona & California as 3005 in May 1996.

It was transferred in September 1997 as <u>Puget</u>
<u>Sound & Pacific</u> 3005. Dan Wilkinson acquired the locomotive in the late 1990's.

Dan donated the locomotive to the Southern Oregon Railway Historical Society in June 2022.

Since the GP30 never operated in our region the SORHS board decided to sell the locomotive and use the funds for continued restoration of Medco #4.

The restoration is currently progressing in White City. When completed it will be leased to the Mt. Hood Scenic Railway to haul their tourist trains.
