### Greetings All:

I have missed the first two run days this year due to my father's illness and ultimate passing. I hope this newsletter finds you all well and I hope to see many of you on Mother's Day for our first run day in May. I am told our first two run days were quite successful and thank you everyone who stepped up to make sure that they were.

I am simply combining the last three months into this newsletter, which I am calling our "Spring 2023" newsletter. However, they will be published monthly from this point forward. I did want to remind anyone who may not have paid their annual dues to please do so as soon as possible, and, of course, we always need extra hands to cover the various areas and jobs during our run days, as well as general maintenance.

I will be going to the park in a day or two and making sure things are ready in the burger shack for our Mother's Day run, weeding, and planting a few flowers, etc. My story today comes from my great grandmother. I found her jottings while looking through family history with my aunt. It seems my maternal side of the family has had some adventures on their train travels.

### **Shaming a Would-Be Train Robber**

On a trip between Oregon and Kansas, my great grandmother and grandmother encountered two unlikely train robbers. These robbers were just young boys, ages about 15 and 16, according to my great grandmother's notes.

Grandma writes that on the first evening of their journey, two masked robbers entered the car where she and my grandmother were riding. Exactly how or where they had originally boarded the train is unknown to me and perhaps to my grandmother and great-grandmother.

However, as the story goes, these two young hoodlums (as my grandmother would have called them, I'm sure) entered the train brandishing what appeared to be a pistol each and demanding that the passengers empty their pockets, pocketbooks, remove watches, necklaces, etc. and place everything in a bag held by one of the robbers.

Now these two boys were not very experienced in robbing trains, as they picked a train that was more or less local to where they lived in Kansas, where my grandmother was born and raised and lived at the time.

#### As my great-grandmother wrote:

"I knew immediately that young James was the boy who appeared to be the leader and shouting orders at us and his young partner in crime. I was not about to give this wayward boy my grandmother's necklace, and I told Neta (my grandmother) not to give them her valuables.

When James ordered me to take off my necklace and empty my pocketbook, I sternly told him I would do no such thing and that he should be ashamed of himself for trying to rob his neighbors and friends of his family. I told him I knew his mother and she would learn about his misbehavior as soon as I arrived home."

Apparently, James was taken aback by this and, according to my great-grandmother, began to "hem and haw" and stutter. My great-grandmother told him she would see to it that his father "tanned his hide". This obviously hit home because my great-grandmother said that James began to cry and say he was sorry and please, please do not tell his father and the two would-be

robbers dropped their bag and left the train, which at the time was just one town over from where they lived.

I did not know my great-grandmother, but I could definitely see my grandmother reacting this same way. The story had my aunt and I laughing until we were in tears. I am not sure if great-grandmother informed the parents of the boy or not, but I would hope that it was the beginning and end of a very short trainrobbing career.
